Waterdam Church Site Plan

I have been on this project for the last six months. In 2016 the master plan was approved. We are now requesting the final approval of Phase 1. We worked two years with DEP to obtain our NPDS permits. We got all that in last year along with the HOP. Now we are presenting it to you. I know you have some concerns in the letter of denial. The biggest reason for the denial letter was the traffic impact. We presented the traffic study to you. We are requesting the final approval for Phase 1. We have met all the requirements. Do you have any questions?

Mr. Ross questioned what is the requirement on Linden Road for the entrance?

Mr. Mikec responded the HOP was cutting the hills back to increase site distance. We have over the required minimum site distance.
